

Admission Requirements:

The following are admissions criteria for applicants to the Truck Driver Training (TDT) program. Applicants for admission to the TDT program must:

1. Complete the North Carolina Residency Determination (Required for all NC Community Colleges).

2. Complete the Application for Admissions online at www.DavidsonCCC.edu
3. Possess Class A CDL Learner's Permit (without Air Brake Restriction). Possess Class A CDL Learner's Permit (without Air Brake Restriction) Permit must remain valid through completion of the program. A free copy of the NC Commercial Driver's Manual is available at any DMV Driver's License Office. Also check www.ncdot.gov/dmv to review the manual online.
4. Provide valid DOT Physical Medical Examination Report form and Certificate as required by the Department of Transportation. These documents are provided by the medical examiner and must remain valid through completion of the program and performed by a federally approved doctor. Physical Requirements

Due to the nature of work in the truck driving industry, there are certain physical requirements which are necessary in order to successfully obtain a Class A Commercial Driver's License and work in the industry. Students are evaluated on the second day of class in order to determine if they can do the following: enter and exit the cab safely, enter and exit the trailer safely, press in the clutch, go under the trailer and check the coupling, and go behind the cab and check the connections. Anyone not able to meet these physical requirements will be dismissed from the program at this point.

Background Check

While DCCC has an open admissions policy, many employers require criminal background checks and will not hire convicted felons. Presence of a felony, DUI or DWI, hit and run, careless and reckless driving, or refusing to take a chemical test on your record may severely limit your employment opportunities in this field.
